Controllers of Personal Information

Any personal information provided to or to be gathered by writersportal.org is controlled by company.

Collection and use of your personal information

The information we receive from customers helps us personalize and continually improve your website experience.

When you use this site you will be asked to provide information such as your contact details. We will store this data and hold it on computers or otherwise. We will use this data to fulfill our agreement with you.

For data transfer we use a security system together with encryption, offering an extremely high level of data safety. Those areas of the website protected by this system will display a closed padlock in your browser.
